O R D E R

Heard Mr.Raju Ramachandran, learned senior counsel
along with Mr.Amitesh Kumar, learned counsel for the
petitioners and Mr.Anil Soni, learned counsel for All
India Council for Technical Education (AICTE).

It is submitted by Mr.Raju Ramachandran, learned
senior counsel that the only deficiency that has been

pointed out by AICTE is that the petitioner-institution has not shifted to the bigger campus which is required. Learned senior counsel would submit that infrastructure is ready and they will shift all the necessary equipments by 10th September, 2017. Mr. Anil Soni, learned counsel for the respondent submits that there shall be two inspections, one to see the nature of complex and the other to see the instruments, etc.

In view of the aforesaid, we direct the AICTE to cause first inspection by 25th August, 2017 and the second one by 8th September, 2017.

In the meantime the petitioner-institution shall be granted permission to admit students for academic session 2017-2018. If after inspection any deficiency is noticed the same shall be removed by the petitioners within three weeks. If the deficiencies are not removed the students shall prosecute studies but the college shall not admit students for the next academic year 2018-2019. The deficiencies to be pointed out by the AICTE would not take into consideration the "occupancy certificate" as presently there is no authority available for grant of occupancy certificate. However, the respondent No.8-Ulhasnagar Municipal Corporation shall scrutinize the papers of the petitioners and pass an appropriate order with regard to grant of occupancy certificate/provisional occupancy certificate within two weeks.

The special leave petition stands disposed of accordingly. No order as to costs.
